HOUSEKEEPING:

Control Panel:

By default the control panel is set to auto-hide.

By moving your curser to the bottom of the screen the control panel will appear.
 The control panel includes the mute, chat, raise hand and Q&A functions.



Mute: By default, you will be put on Mute when you join the Webinar.



Hand raising:

The hand raising feature is found on the middle of the Zoom control panel.

By default, your hand will not be raised.

When your hand is down, the button look like this:

Is there a sufficient volume of knowledge based service your practice provides to be financially sustainable?










WHAT IS DOXY.ME AND WHAT PLAN IS A GOOD FIT?

- Doxy.me is a telemedicine platform
 - Offers video, phone, and messaging
 - It is HIPAA compliant and web browser based
 - It is NOT an EMR



- Free
 - Cost-free entry into telemedicine;
 Waiting room, patient queue, text chat, meeting history, notifications
- Professional
 - Free plus offers group calling, photo capture, screen/file sharing and passcode
 - No contract, month to month
- Clinic
 - Professional plus group waiting room and shared calls
 - Suited for group clinic and team based care







WHAT IS NEEDED TO SUPPORT DOXY.ME VISIT?

- PC, Tablet, and Mobile
- Computer camera
 - Can screen and file share WITHOUT camera
- Microphone
 - Can messaging WITHOUT microphone
- High speed internet
 - Limiting factor
- Location
 - Quiet and secure
 - Home vs office depends on office workflow (e.g. VoIP, eFaxing etc)








THE BOTTOMLINE...

Any physician that has access to a smartphone has the ability start telemedicine video visits using Doxy.me today.







PEARLS - HOW TO INTEGRATE DOXY.ME INTO CLINICAL PRACTICE

Engage your staff - early

- Buy-in, collaboration and understanding of value
- Gain insight of how your practice
 ACTUALLY works



Practice, practice, practice

- Start with supportive friends, family, colleagues, staff and patients
- Practice with staff very important
- Different devices, operating systems (e.g. Windows/ Mac, Android/ iPhones)
- Troubleshooting tips
 - Most common issue: Browser settings and camera/microphone permissions
 - When in doubt refresh your browser





PEARLS - ENGAGING AND INFORMING PATIENTS

- Collaborate with your staff
 - How is information shared with patients?
 - How can communication be enhanced?



- On the front door; In common areas, exam rooms/bathrooms
- Phones
 - Staff; answer machine messages
- Email
 - Individual email footers; no-reply email servers e.g. MailChimp
- Online booking
 - Clinic profile; patient appointment reminders
- Website
 - Patient education; direct Doxy.me access to virtual waiting room
- Social media
 - DoBC Public Campaign Feb 7th







PEARLS - HOW TO HAVE SUCCESSFUL DOXY.ME APPOINTMENT

The patient perspective:

- Have the virtual waiting room web address in ALL appointment reminders
 - Make access as frictionless as possible
- Have the patient start their first virtual appointment 30 min early
 - Gives ample time for troubleshooting
- Remind patients to wait in the virtual waiting room and be patient









PEARLS - HOW TO HAVE SUCCESSFUL DOXY.ME APPOINTMENT

The physician and staff perspective:

- Your "set-up"
 - Mobile phone vs computer only vs combination
- Refresh browser often
- "Staff huddles"
 - Staff sign into physician Doxy.me virtual waiting room
 - Physician puts staff members "on hold" to message and talk to staff
- Keep your waiting room locked to prevent patients from entering (Pro and Clinic versions)
 - "Turn off" passcode at start of day
 - "Turn on" passcode at the end of day









PEARLS - THINGS TO CONSIDER DURING VIRTUAL VISITS

Send message to patients in the virtual waiting room

"I'll be right with you."

- Late patients
 - Send patient an invite by text and email
 - If no response, staff to contact to rebook or troubleshoot etc.
 - See or invite the next patient on your day sheet
- Creative assessments
 - Video/ pictures by email, remote monitoring devices, Roth test
- Gather additional information
 - Pharmacy, lab/ imaging locations
- File transfer can be used like e-Faxing to deliver documents to patients
 - Lab and x-ray requisitions only

TELEMEDICINE AND CLINIC WORKFLOW

- Telemedicine does not mean working remote
- Working remote requires:
 - EMR with remote access
 - Mobile phones or VoIP apps
 - eFaxing (e.i. prescriptions)
 - Scanning
 - Online booking (e.g. patient follow up)



- If you cannot work remotely, do telemedicine in your office
 - Your usual clinic workflows are supported.
 - Prevent burden of work placed on physicians and staff with more faxing/ phoning of prescriptions and requisitions.
- Consider implementing more remote solutions to your practice in the future.
