The legal weight and authority of the UNHCR *Handbook on Procedures and Criteria for Determining Refugee Status* in interpreting and applying the refugee definition and the provisions of the 1951 Convention relating to the Status of Refugees and its 1967 Protocol has been recognized by courts and other adjudicative bodies throughout the world, including the United States Supreme Court beginning with its leading decision on U.S. asylum law, *INS. v. Cardoza-Fonseca*, 480 U.S. 421 (1987).

Guidelines on International Protection

UNHCR issues Guidelines on International Protection pursuant to its mandate, as contained in the *Statute of the Office of the United Nations High Commissioner for Refugees*, in conjunction with Article 35 of the 1951 Convention relating to the Status of Refugees and Article II of its 1967 Protocol. These Guidelines complement UNHCR's *Handbook on Procedures and Criteria for Determining Refugee Status under the 1951 Convention and the 1967 Protocol relating to the Status of Refugees* (1979, re-edited, Geneva, January 1992). These Guidelines are intended to provide legal interpretative guidance for governments, legal practitioners, decision-makers and the judiciary, as well as UNHCR staff carrying out refugee status determination in the field.
